Is NTEU asking for big improvements? We are asking for more pay and some travel items. However, it seems NCUA wants to take everything away. Many of these things would have been implemented if it was not for the union.

OPM examiner survey did not request whether we needed training in BSA or IS&T.

A lot of mid-term bargaining – office moves, implementation of new performance standards, office painting, etc.

Ray has been out of the picture since he left NCUA, and has promised to resign. We have been concentrating on the contract, but will get back with Ray about the issue.

Performance system has been used to over-weight management and to over-reward management.
